# EVEN AFTER DEC. 31, 2018, YOU AND YOUR FAMILY MIGHT STILL QUALIFY FOR LUXEMBOURG DUAL CITIZENSHIP! READ ON.....

The deadline for applying for Luxembourg Dual Citizenship will end for many people on December 31, 2018. But, due to a recent reform of the Luxembourg Nationality Law (the reform is called Article 7), numerous individuals who qualify for Luxembourg Dual Citizenship still have time to apply (they are not bound by the first deadline of December 31, 2018 nor the final deadline of December 31, 2020)! So, Luxembourg Dual Citizenship still could be yours! But read on......

The other amazing news is that individuals who still qualify for Luxembourg Dual Citizenship under the Article 7 reform, need only do Stage 1 of the process (submission of necessary ancestral documents) and you will receive "automatic" Luxembourg Nationality without have to do Stage 2 – the formal application stage where you need to go Luxembourg. So, Article 7 qualifiers are exempt from having to go to Luxembourg to apply.

To still qualify to apply for Luxembourg Dual Citizenship under the Article 7 reform (even after December 31, 2018), your Luxembourg ancestral line must match one of the "ALL-MALE" ancestral scenarios listed below:

#### **SCENARIO #1**

You come from an ALL-MALE Luxembourg lineage down to you — a MALE. You must have a direct-line, male ancestor (either father, grandfather, g-grandfather, g-g-grandfather, etc.) who was born in Luxembourg. It does NOT matter where or when he lived and died, as long as he was born in Luxembourg.

MALE ANCESTOR #1 (MUST HAVE BEEN BORN IN LUXEMBOURG)



MALE ANCESTOR #2 (BORN IN USA OR ANYWHERE)



MALE ANCESTOR #3 (BORN IN USA OR ANYWHERE)

If you are a MALE and come from such an ALL-MALE, Luxembourg lineage, then you, your children (male and/or female) and grandchildren (male and/or female) can still apply for Luxembourg Dual Citizenship EVEN AFTER DECEMBER 31, 2018! You still qualify to apply under Article 7. You, your children and grandchildren only have to complete Stage 1 of the process and you will "automatically" get Luxembourg Dual Citizenship!

#### **SCENARIO 2**

You come from an ALL-MALE Luxembourg lineage down to you — a FEMALE. You must have a direct-line, male ancestor (either father, grandfather, g-grandfather, g-g-grandfather, etc.) who was born in Luxembourg. It does NOT matter where or when he lived and died, as long as he was born in Luxembourg.

MALE ANCESTOR #3 (BORN IN USA OR ANYWHERE)



YOU (A FEMALE)



If you are a FEMALE and come from such an ALL-MALE, Luxembourg lineage, then YOU can still apply for Luxembourg Dual Citizenship EVEN AFTER DECEMBER 31, 2018! You still qualify to apply under Article 7. You only have to complete Stage 1 of the process and you will "automatically" get Luxembourg Dual Citizenship!

### BUT, AS A WOMAN, WHAT ABOUT YOUR CHILDREN AND GRANDCHILDREN?

If your child was born AFTER JANUARY 1, 1969, then that child/ren (male and/or female) and all of your grandchildren (male and/or female) from that child, still qualify to apply for Luxembourg Dual Citizenship. They still qualify to apply under Article 7 and only have to complete Stage 1 of the process to attain "automatic" Luxembourg Dual Citizenship.

If your child was born BEFORE JANUARY 1, 1969, then unfortunately, that child and your grandchildren born to them, DO NOT qualify any longer to apply for Luxembourg Dual Citizenship. They DO NOT qualify for the Article 7 reform of the law.

These scenarios can be a bit confusing!
